



## **INTRODUCTION**

The purpose of this document is to provide information relating to the installation, safe operation, care and maintenance of the **multiLift2**.

### **Intended Lift User**

S.R.Smith's lifts have been designed to assist individuals requiring assistance entering or exiting a swimming pool or spa. The user must not exceed the weight limit of the product (350 lb. / 158.75 kg). It is the responsibility of the lift owner to ensure that safety procedures are put in place and a risk assessment is completed. Mental or physical disabilities may require assisted transfer, and the owner is responsible for determining the number of qualified attendants to complete the poolside transfer and the number of persons required to be in the water, ready to receive and assist the user. The seatbelt must be attached to the seat, fully fastened and used during each transfer.

Our goal is to provide our customers with the most advanced and innovative designs offering exceptional quality at affordable prices. All S.R.Smith lifts meet the specifications set forth by the Access Board - ADAAG 2004. The lift system and AC powered battery charger complies with EN60601-1-2, 2007/03.

### **Using the multiLift2**

Obey all User Instructions listed in the Owner's Manual whenever using lift. Obey all Caution, Warning, Operating Instruction(s) and Labels located on the lift whenever using. It is the responsibility of the lift Owner to ensure that the correct safety procedures have been put in place and a risk assessment carried out. If a User is mentally challenged or has physical disabilities these issues must be considered to determine the number of persons required to complete the transfer onto the seat and the number of persons required to be in the water, ready to receive the User. If the multiLift2 will be used by a disabled person living on their own, a communication device should be installed in the area of use to call for assistance in the event of an emergency. Only persons healthy enough for water activities should use the multiLift2. Users should consult with their physician to determine if water activities are appropriate for the User. Keep fingers and hands clear of lift arms during use.

### **WARNING**

- The battery must be completely removed from lift and located away from pool deck for charging.

When **YELLOW** <50% charge level is shown the battery must be fully charged before use. When **RED** <25% charge level is shown the lift must not be used and the battery must be fully charged before use.
- **DAMAGE MAY RESULT** - Do not allow excessive moisture to collect in the battery case, it can affect battery and lift performance and could lead to battery failure and/or the lift failing to operate.

### **ADA GUIDELINE SUMMARY\*** (USA Only)

#### *1009.2.1 Pool Lift Location*

Pool lift shall be located where the water level does not exceed 48". If entire pool water level exceeds 48", place pool lift where convenient.

#### *1009.2.2 Seat Location*

In the raised position, the centerline of the seat shall be located over the deck a minimum of 16" from the edge of the pool.

#### *1009.2.3 Clear Deck Space*

On the side of the seat opposite the water; a clear deck space shall be provided parallel with the seat. The space shall be 36" wide minimum and shall extend forward 48" minimum from a line located 12" behind the rear edge of the seat.

#### *1009.2.4 Seat Height*

The lift shall stop at 16" – 19" measured from the deck to the top of the seat surface when in the loading position.

#### *1009.2.8 Submerged Depth*

The lift shall submerge the seat a minimum of 18" below the stationary water level.

# multiLift2 AQUATIC LIFT SYSTEM

## PRODUCT OVERVIEW

The multiLift2 Aquatic Lift is a fixed lift system designed so that individuals with disabilities and mobility impairments can have access to residential, hospitality and multi-unit facility swimming pools or spas. The multiLift2 is powered by a 24-volt rechargeable battery operated by a screw driven electronic actuator that provides the lifting and lowering motions. Following all instructions in the Owner’s Manual and all product labels is necessary to achieve safe, reliable, and proper performance of the lift and avoid injury. This ensures consistent safe operation and minimizes service problems.

The multiLift2 has a mast height of 58.5 in / 148.6 cm above the deck. It is intended to be used with simple pool gutter configurations having a deck to water distance of no more than 14.5”, see Figure 19 on page 24 to determine if the multiLift2 is appropriate for use on a specific pool. The maximum weight capacity for multiLift2 is 350 lb. / 158.75 kg. Only persons healthy enough for water activities should use the multiLift2. Users should consult with their physician to determine if water activities are appropriate for the user.



## COMPONENT DESCRIPTION

The lift is made up of several main components:

**multiLift2 Assembly-** Primary lift assembly includes frame components, mounting base, and actuator. All metal lift components are manufactured from stainless steel or aluminum and powder-coated for additional corrosion protection. The multiLift2 can be assembled in either a right side or left side, field reversible, seat configuration.

**Seat Assembly -** The seat is manufactured from roto-molded plastic with a stainless-steel frame. The seat comes standard with a seatbelt. The seatbelt must be used during each use. It is recommended that the seat be rinsed off with fresh water between each use and cleansed daily with a disinfectant solution of 1:100 dilution of household bleach to fresh water and then rinsed with fresh water. In the event of a contamination incident such as patient/user excreta - cleanse seat and seatbelt immediately with the above disinfectant solution. Do not use seatbelt if it is damaged or becomes worn.

The armrests are designed for support when transferring onto the seat. They can be rotated up out of the way during transfer.

The lift seat assembly is designed to be used exclusively with S.R.Smith aquatic access lifts.

**Footrest-** The footrest is constructed of roto-molded plastic and is easily removable.

**Control Box -** The LiftOperator unit controls all lift operations identical to the user handset. Two cables connect to the bottom of the Control Box to enable operation of the lift. The largest connector is for the hand control. Connector # 2 is for the actuator cable.

### Touchpad Control –

The touchpad control arrow keys can be used in the event the Hand Control is out of reach or fails. Simply press and hold the arrow for the desired action for one movement at a time – Up, Down, Releasing the Arrow stops movement.

### Battery Level LED Indicators –

The Battery Level LED Indicators show battery charge levels. The LED's will illuminate when either the touchpad control or the Hand Control is activated and will stay lit for 10 seconds. At greater than 50% the LED glows Green, at less than 50% the LED glows Amber, and less than 25% the LED glows Red and indicates the battery requires charging. If the less than 25% LED glows Red, do not operate the lift. Remove the battery and fully charge before use.

### Service Required LED –

The Service Required LED will illuminate when the battery pack has been removed/replaced 120 times - approximately once every 4 months. This indicates that required maintenance for the lift must be completed. Please see the Maintenance Section of the Lift Owner's Manual for the requirements. The Service Required LED can be reset by inserting a standard FAT-formatted USB mass storage device (not included) into the USB Port on the bottom of the controller. **When the service light is illuminated the lift must not be used until required maintenance is performed.**

## Emergency Stop Button –

In the event of an emergency, or if you need to stop lift movement immediately, pressing the Emergency Stop Button (red button on the control) will stop all lift movement. At the same time an audible alert will sound for 10 sec. then pause for 5 sec. and then the sequence will repeat until the button is reset by turning it in the direction of the arrows on the button (clockwise). The Emergency Alert LED will also flash Red when the button is pressed and will remain flashing until the button is reset.

The Emergency Alert (audible and LED) can be activated by pressing any two buttons on the Hand Control at the same time (provided with the lift). This will stop all lift movement and activate the audible alert and the Red LED will flash. Once both buttons are released, the lift will return to normal operation and the emergency audible alert will silence.


## USB Port –

The LiftOperator control contains a USB port that is used to download the performance log of the lift. Using any standard FAT file formatted USB memory stick (widely available through retail outlets) insert the stick into the slot on the bottom of the control on the far-right hand side. Press any of the touchpad control arrows; all three of the Battery Level LED's will flash. During downloading the Green greater than 50% Battery Level LED will flash. If the unit has a problem downloading the performance log the Red less than 25% LED will flash. Remove the USB from the port and re-insert it. If the Red 25% LED flashes again, confirm that the USB you are using is FAT file formatted. The information from the USB can be downloaded to a PC for review and/or copied to a spread sheet. The performance log will retain approximately 7,600 events. Once the file is full it will remove the oldest event and replace with the newest. After the summary data, the events are shown with the oldest first. The first column is the time in seconds from that last event. The second column is the text describing the event. The third column is duration of the activity noted in seconds.

**Battery Pack** - The battery pack is located on top of the Control Box and is removable.



**To remove - pull the battery pack away from the mounting plate so that the latch on the battery pack clears the side tabs on the mounting plate - then lift the battery pack up and away from the Control Box.**

**To replace - align the battery pack with the mounting plate so that the latch will drop over the center tab and that the bottom of the battery pack will fit in the recessed area on top of the Control Box. Lower the battery pack in place so that the latch is fully captured by the mounting plate and the battery pack drops fully seated onto the Control Box.**

**The battery must be completely removed from the lift and located away from the pool deck for charging.**

The battery pack should be charged daily. **Do not allow battery to fully discharge, as it will shorten battery life.**

The battery pack has an LED indicator near the plug-in-port. It will glow Red when first plugged into the transformer. If the LED remains Red, this indicates the battery pack needs charging. When fully charged the LED will glow Green. If the battery is fully charged and is plugged into the transformer the LED will glow Red for approximately 10 sec., then glow Green. If the LED flashes Red when plugged in this indicates a fault with the battery and indicates the battery pack should be replaced. All batteries are inspected prior to shipment. See warranty policy regarding battery replacement for problems after sale. Batteries have a normal lifespan of between 2-3 years, depending on use and care. A fully charged battery will provide approximately 30 to 40-lifting cycles, depending on the weight of the users. Prior to use the battery charge level should be checked by observing the LED indicator above the charger plug to ensure sufficient charge level. The charger must be connected to the battery to view the LED.





It is not necessary to fully discharge the battery prior to charging. Battery should be charged daily and cannot be overcharged. It takes up to twelve hours to fully charge depending upon battery usage

Do not drop the battery, as it could cause the unit to fail. If the battery case is cracked do not use and replace the battery. During temperature extremes beyond the range of 41°F (5°C) to 104°F (40°C) remove battery and place in a controlled environment or battery life may be shortened.

**Battery Disposal** - The batteries located inside the battery pack are recyclable and shall be disposed of in accordance with applicable local, state/provincial, or federal/national regulations.

**Locking Plate Assembly** - The battery pack can be secured to the mounting plate using the provided lock plate assembly. To install open the lock plate so that the bottom tabs are moved close to one another to allow the lock plate to be inserted into the slots on the mounting plate secured to the lift. Close the lock plate assembly so that the tabs are captured by the slots. Insert a padlock (not provided) through the holes on the lock plate assembly to secure it.



**Hand Control** – The two button unit controls lift movement. The arrows indicate direction of movement. The Hand Control is fully waterproof and meets IP67 standards.

## READ THESE INSTRUCTIONS IN THEIR ENTIRETY BEFORE BEGINNING INSTALLATION

Prior to opening the shipping container, carefully inspect the external condition of the shipping materials for any visible damage. It is important that any damage be noted on the Bill of Lading prior to signing for the delivery. Contact either S.R.Smith or your dealer immediately to notify us of any damage or missing parts.

Ensure mounting anchors have been installed in the correct location in the pool deck for proper lift operation. It is recommended that the deck anchors be installed by a person familiar with installing pool deck equipment. The multiLift2 can be installed using existing multiLift™ and ML300 anchors.



The multiLift2 is shipped partially assembled. Position container(s) close to deck anchors for easier assembly and set up.

### Unpacking & Assembly Procedure for the multiLift2:

1. Carefully remove all lift components from packaging.
2. Remove seat assembly and footrest and set aside for attachment.
3. Align slotted holes in the base mounting plate with deck anchors. Position the front edge of the lift base plate so that it is located 8.75" minimum and 13.75" maximum from the pool edge. See Figure 19 on page 24.
4. Locate the deck mounting hardware in the accessory carton and use the hardware to fasten the multiLift2 to the anchors as shown in **Figure 4**. Use a  $\frac{3}{4}$ " wrench to tighten the bolts down until the lock washers are fully compressed. **Note: Anti-seize compound must be used on the stainless-steel mounting bolts to prevent seizing in the deck anchors.**





## RIGHT SIDE SEAT MOUNT CONFIGURATION

**Caution:** During assembly, ensure the lift actuator motor is positioned away from the seat leveling arm. Failure to install the seat leveling arm on the side of the lift opposite to the lift actuator motor will cause interference and damage to the lift components. Figure 5 shows the correct position for the actuator and seat leveling arm for a right seat mounting configuration.






7. Install the seat arm to the multiLift2 assembly by using Hardware Kit 580-7000 as shown in Figure 6.




## LEFT SIDE SEAT MOUNT CONFIGURATION

**Caution:** During assembly, ensure the lift actuator motor is positioned away from the seat leveling arm. Failure to install the seat leveling arm on the side of the lift opposite to the lift actuator motor will cause interference and damage to the lift components. Figure 9 shows the correct position for the actuator and seat leveling arm for a left seat mounting configuration. The main assembly for the multiLift2 is shipped with the actuator installed in the right seat mount configuration. When assembling the lift for a left seat mount configuration, the actuator must be detached from the base, rotated 180 degrees and reattached.



13. Remove the hardware connecting the actuator to the base. Rotate the actuator 180 degrees so that it is in the position shown in Figure 9 and reattach the actuator. Figure 10 shows the re-assembly sequence for bolt, washer, spacers, and nut.







14. Install the lift seat arm to the multiLift2 assembly by using Hardware Kit 580-7000 as shown in Figure 11:

15. Tighten bolt and lock nut until snug; then back off 1/2 rotation.




16. Next attach the seat leveling arm to the seat arm as shown in Figure 12.

20. Locate Seat Assembly and attach to Seat Frame using bolt (2) Washers, and. (1) Acorn Nut Tighten using (2) ½" Box Wrenches. See Figure 14.



21. Attach the Footrest to the Seat using (2) bolts and (2) 4-arm knobs through holes on bottom of Seat and Footrest. See Figure 15.



22. Install the LiftOperator Control to the mounting bracket by inserting the tabs on the bottom of the mounting bracket into the slots in the lower backside of the controller. Secure the controller to the bracket by installing the #10-32 X 3/8 screw and tightening with the wrench provided. See Figure 16.



23. Remove the Hand Control from accessory carton and unwrap. Insert Hand Control plug into large socket on the LiftOperator Control Box shown in Figure 17. Next, install the actuator plug into the socket shown in Figure 17. Route actuator cable from the motor as shown in Figure 17.



24. Attach battery to LiftOperator Control Box making sure that the battery latch bracket locks into the slots on the control unit mounting bracket. To remove the battery from the control unit, pull outward on the battery handle until the battery latch bracket clears the slots in the control unit mounting bracket, then pull upward, see Figure 18.




25. Check all controls and emergency stop button for proper operation. See LiftOperator Owner's Manual for details.

## POOL DECK INSTALLATION FOR THE multiLift2

Ensure the anchors have been installed in the correct location in the pool deck for proper lift operation. It is recommended that the anchor be installed by a person familiar with installing pool deck equipment. The pool owner is responsible for ensuring that all applicable ordinances are followed when installing the lift.

The optimal mounting distance for the deck front anchors is 12.5" / 31.75 cm from the edge of the pool. The front anchors can be installed up to a maximum of 17" / 43.18 cm from the edge of the pool. The setback distance from the pool edge to the front anchor locations varies depending upon pool geometry. The multiLift2 is designed to be used with simple pool edge designs with deck to water level differences of up to 14.5" maximum, see Figure 19.

Please contact S.R.Smith with any questions concerning deck anchor placement or to determine if the multiLift2 is the best choice for your installation.

## INSTALLING ANCHORS INTO EXISTING CONCRETE DECK



Follow these guidelines to make sure that your anchors are installed properly:

- Minimum concrete slab requirements for the multiLift2:
  - Slab dimensions should be at least 42" X 60" X 4", reinforced. See Figure 20 above.
  - Anchors shall be installed at a minimum of 4" or greater from the edge of the slab or expansion joint.
  - Existing slab shall exhibit no signs of cracking or deterioration.
- S.R.Smith recommends using Simpson SET epoxy adhesives or equivalent for installation of the deck anchors. Use epoxy adhesives per the manufacturer's instructions.
- Use Figure 19 to determine the proper location to install the lift, making certain that the front anchors are located the correct distance from the pool edge
- Layout and mark the hole locations on the deck using the multiLift2 Anchor Set Jig as a template.
- Drill four holes 1.125" diameter and 3.625" deep in the locations marked in step 2. **Note:** The hole that the bondable anchor will be inserted into will need to be slightly deeper than the others. It is recommended that the anchors are placed into each hole prior to pouring the epoxy to ensure that the holes are drilled to the proper depth.

6. Clean all dust and debris from the holes.
7. Bond at least one of the flush deck anchors per local codes. Contact your local Authority having jurisdiction for the bonding requirements in your area. A threaded hole for attaching a bonding screw is provided on bottom side of one of the deck anchors. Use the screw provided with the deck anchor kit to attach the bonding wire to the deck anchor. See Figure 21.



8. The multiLift2 Anchor Jig must be used to ensure that the anchors are held in the correct position until the epoxy is cured. To use the Anchor Jig, place the 1/2"-13 X 2" Hex Bolts through the tubes in the Anchor Jig and thread the bolts into the anchors until the top surface of the anchors contact the bottom of the Anchor Jig tubes. See Figure 22.



9. 1-1/2" blocks can be used as spacers between the deck surface and the Anchor Jig to ensure that the tops of the anchors are flush with the deck surface.
10. Fill holes approximately half full of epoxy.
11. Insert deck anchors, making sure that the anchors are flush with the top of the deck.
12. Remove any excess epoxy immediately. See figure 23
13. Allow the epoxy to cure per the manufacturer's instructions.
14. Once the epoxy has cured, install the lift per the installation instructions.



# INSTALLING ANCHOR JIG INTO NEW CONCRETE DECK



Follow these guidelines to make sure that your anchor jig is installed properly:

1. Minimum concrete slab requirements for the multiLift2:
  - Slab dimensions should be at least 42" X 60" X 4", see Figure 23 above.
  - Anchors shall be installed at a minimum of 4" or greater from the edge of the slab or expansion joint.
  - Normal weight of concrete = 150 lbs/ft<sup>3</sup>
  - Concrete minimum compressive strength at 28 days to be F'c =2500 psi.
  - Reinforcing bars shall conform to ASTM A615 Grade 60, deformed.
2. Use Figure 19 to determine the proper location to install the lift, making certain that the front anchors are located the correct distance from the pool edge.
3. Assemble the deck anchors to the anchor jig as described in **Appendix B**
4. on page 36.
5. Install the anchor jig and reinforcing rods per Figure 23.
6. Use the bonding lug provided on the anchor jig to attach the bonding wire per local codes. Contact your local Authority having jurisdiction for the bonding requirements in your area.
7. Make sure that the top of the anchors are flush with the top surface of the slab.
8. Allow concrete to cure per manufacturer's instructions.
9. Once the concrete has cured, install the lift per the installation instructions.

### USING THE multiLift2

Obey all User Instructions listed in the Owner's Manual whenever using lift. Obey all Caution, Warning, Operating Instruction(s) and Labels located on the lift whenever using. It is the responsibility of the lift Owner to ensure that the correct safety procedures have been put in place and a risk assessment carried out. If a User is mentally challenged or has physical disabilities these issues must be taken into account to determine the number of persons required to complete the transfer onto the seat and the number of persons required to be in the water, ready to receive the User. If the multiLift2 will be used by a disabled person living on their own, a communication device should be installed in the area to call for assistance in the event of an emergency. Only persons healthy enough for water activities should use the multiLift2. Users should consult with their physician to determine if water activities are appropriate for the User. Keep fingers and hands clear of lift arms during use.

### multiLift2 Transferring Diagram



## TRANSFERRING THE USER TO THE WATER

Once the unit is positioned for use, use the following procedure to transfer to the seat and into the water. Only persons healthy enough for water activities should use the multiLift2. Users should consult with their physician to determine if water activities are appropriate for the User:

- Check battery level of LiftOperator to ensure charge is adequate for operation (at least 50% charge recommended).
- Use the buttons on the Hand Control or control unit front panel to raise the seat to the deck loading position as shown on pages 7 and 10.
- Transfer user onto the seat, ensuring that the user's weight is centered on seat. Armrests can be rotated up if necessary (optional US/standard on EU models). If user has a wheelchair, keep the wheelchair close by for easy retrieval.
- Fasten Seat Belt - thread loose end of belt strap through buckle - pull tight - to close - press latch down on belt material.
- Use the Hand Control or control unit front panel to lower the seat into the water. The waterproof Hand Control can remain connected to seat if user is operating lift.
- Unfasten Seat Belt - grasp latch and lift up, pull loose end from latch.
- When finished, return to the seat, ensuring user's weight is centered on seat.
- Fasten Seat Belt.
- Use the buttons on the Hand Control or control unit front panel to return the seat to the deck loading/unloading position.
- Unfasten Seat Belt.
- Transfer off of the seat.

## IN CASE OF HAND CONTROL FAILURE

**Lifting failure** - In the event of a Hand Control failure, or if the Hand Control is out of reach, there are control buttons built into the touch pad of the Control Box.

**If the multiLift2 will be used by a disabled person at an unsupervised location, a reliable communication device must be installed in the area of use to call for assistance in the event of an emergency.**

## STANDARD ACCESSORIES/OPTIONAL ACCESSORIES

The following items are included with all S.R.Smith pool lift models:

- Seat Belt Assembly - Nylon water-resistant belt for added security.
- Battery/Charger – 24-volt rechargeable battery.

Optional accessories may be purchased for your multiLift2 lift through your Authorized Reseller. The following accessories are available:

**Console/Battery Cover – P/N 910-1000T (Tan):** Protects battery and control unit from exposure to moisture

**P/N 910-1000S (Slate):** Protects battery and control unit from exposure to moisture

**multiLift2 Deck Anchor Kit P/N 300-6700A** – Includes four (4) flush deck anchors.

**New Construction Anchor Jig P/N 500-5000** – Includes anchor jig, and hardware minus the flush deck anchors. See anchor jig assembly info **Appendix B** on page 3836.

## MAINTENANCE and CLEANING

A maintenance program will prolong the life of your lift. Keep all electronic components clean and dry. Keep the console/battery cover installed at all times to prevent moisture from collecting on the Control Box and battery. Excessive moisture collection can affect battery and lift performance and could lead to battery failure and/or the lift failing to operate. **If the lift is used outdoors, an optional full cover is available and recommended.**

Owners of lifts should be aware of any applicable local, state/provincial, or federal/national regulations regarding the inspection and or testing of lifts.

**The following schedule shall be performed to ensure proper operation with the Daily items performed before each use:**

\* When using the disinfection solution avoid direct contact with the skin and eyes. In the event of a contamination incident - immerse the seat belt in the disinfection solution for 10 min. and then rinse thoroughly with fresh water.

## TROUBLE SHOOTING

Lift does not function:

1. Be sure the battery is fully charged before troubleshooting. The battery is fully charged when the charge indicator LED located near the battery charging port is green. If the battery charge indicator light is solid red, let the battery continue to charge until the light turns green. If the battery charge indicator LED is flashing red, it indicates that there is a fault with the battery and the battery should be replaced.
2. Check battery charge level. With the battery connected to the control box, pressing any button on the hand control, or the Control Box front panel, will turn on the Control Box and the battery indicator LEDs will show the charge level of the battery. If the Battery charge level is less than 25% and the battery has been fully charged, the battery needs to be replaced. If no lights come on after the battery is connected to the Control Box and after pushing buttons on the control box, verify that the battery is properly connected to the control box. If the battery has been checked per step 1, then the issue is likely with the control box, and the Control Box will need to be replaced.

Lift will not raise and lower when using the hand control:

1. Check Hand Control connection to control box. Be sure plug is pushed in all the way.
2. Check Hand Control connection to Control Box for damaged pins.
3. Check connection cable for damage.
4. Use the buttons on the front panel of the Control Box to raise and lower the lift. If the lift raises and lowers when using the buttons on the front of the control box, the Hand Control should be replaced.

If none of the above steps work in getting the lift to function, call S.R.Smith for assistance.

## LONG-TERM STORAGE

When storing the lift for an extended period of time:

- Wash seat with disinfectant solution and then rinse with fresh water and dry entire lift
- Keep the battery on the charger in a dry temperature-controlled area
- Cover unit and store in a dry location away from pool chemicals

## WARRANTY INFORMATION

**The S.R.Smith warranty becomes effective on the date of manufacture.**

To initiate a warranty replacement, please follow the process outlined below.

1. **Take photos of the damaged product.**
  - a) The photo must include the entire unit (i.e. board and stand or slide from a distance).
  - b) Also include one photo or more of the damaged area.
2. **Write down or take photo of the serial # sticker from the product.**

S.R.Smith provides a serial # for every board, lift, stand, slide and rail product we produce. The sticker with the serial number for our boards, stands and slides is a silver, 1" long rectangular sticker found on the side or bottom of the item. The serial # sticker for our rail products is clear and 2" long. It will be found on the inside of the topmost curve. The serial # sticker for the lifts is silver and 2 ½" x 3 ¼". It is located on the mast.
3. **Attach the photos and the serial # to a written request for replacement under the S.R. Smith warranty.** Please include the following information:
  - a) Product name and description. (i.e.: board length/color, curve direction of slide, etc.)
  - b) Date of purchase and/or date of installation.
  - c) Description of damage.
  - d) Shipping address with a contact name and phone number.

## Batteries

All batteries are inspected prior to shipment and should be free from defect. See warranty policy regarding battery replacement due to defect. Batteries have a normal lifespan of between 2-3 years, depending on use and care.

Battery should be charged daily. Do not allow battery to fully discharge, as it will shorten battery life. Whenever battery is removed from Control Box or lift is not in use it is important to connect battery to charger. This ensures battery is fully charged and ready for use.

Do not drop the battery, as it could cause the unit to fail. If the battery case is cracked do not use and replace. Battery has contacts located on the bottom of the housing. Do not place on a conductive surface that can cause a short. During temperature extremes beyond the range of 41 F (5 C) to 104 F (40 C) remove battery and place in a controlled environment.

Keep the console/battery cover installed at all times to prevent moisture from collecting on the Control Box and battery. Excessive moisture collection can affect battery and lift performance and could lead to battery failure and/or the lift failing to operate.

## BATTERY DISPOSAL

The battery is recyclable and shall be disposed of in accordance with applicable local, state/provincial, or federal/national regulations.






