### **READ THIS FIRST**

Congratulations on your purchase of a Spa Electrics ATOM Retro Series pool light, for safe and proper installation, please read the installation manual carefully prior to product installation.

For safe & proper installation, use only parts (screws, plugs, sealant etc) provided.



### **ELECTRICAL SUPPLY NOTICE**

The ATOM Retro Series light must only be used with a 12V AC Class 2 power supply or a power source intended for swimming pool use (not included).

Minimum power source wattage requirement - 15 Watts per light.



#### **WARNING**

- The ATOM Retro Series EM Light must be water cooled at all times. DO NOT switch
  the light on until installation is complete and the light is fully submerged in water.
- Ensure sufficient cable is coiled behind the light to allow for servicing
- Ensure only circular cable not exceeding 14mm diameter is connected to the supplied cable joiner. The use of Figure 8 or non circular cable will prevent correct sealing & will void the product warranty.
- The ATOM Retro Series EM Light does not contain any user serviceable parts, opening the light will void the product warranty.
- Pool chemicals & PH levels: Due to the corrosive nature of unbalanced pool chemicals, Spa Electrics strongly recommends that your pool water is balanced prior to installing your pool Lights or any plastic or stainless steel components, and tested weekly to maintain these levels. pH levels should be maintained between 7.2-7.6 at all times to ensure the longevity of these components.
  - Failure to do so can result in chemical damage to the light housing and pool fittings, including stainless steel components.
  - Please note: Lights or components found to have excessive chemical damage will not be covered under our manufacturer's warranty policy

#### TOOLS REQUIRED

- → Small **flat-blade** screwdriver (supplied)
- → 24mm / 29mm spanner (supplied)
- → Side cutters / Pliers



#### **IMPORTANT NOTES**


- The use of power tools during installation is <u>not</u> recommended as these devices can cause faults and damage to light components.
- All installation steps should be carried out with manual tools only.

#### WINTERIZATION

- All ATOM Retro Series Lights must be removed from niche (Pg.12) and lowered to pool floor during periods of pool water freezing.
- Pre-existing niches should be adequately protected during winter months as per manufacturers recommendations.
- Consult your local pool professional for complete pool winterization process.




### **BEFORE YOU START**


#### 2 CHECK TRANSFORMER

### EXISTING TRANSFORMER **MUST** BE:

- 12V AC CLASS 2 POWER SUPPLY/POWER SOURCE INTENDED FOR SWIMMING POOL USE
- MIN. 15 WATT (PER LIGHT)
- IN GOOD WORKING ORDER

# EXISTING TRANSFORMER **MUST NOT** BE:


- DC OR 'LED DRIVER'
- ELECTRONIC OR SWITCH MODE
- WEATHER DAMAGED OR IN OTHERWISE POOR CONDITION




## **REMOVAL OF EXISTING LIGHT**




#### 2 PREPARING EXISTING CABLE




### **INSTALLING CABLE JOINER**

# **IMPORTANT**




#### 1 OPEN CABLE JOINER

LOOSEN OUTER CABLE GLAND NUTS.



LOOSEN AND REMOVE BOTH THREADED HEX NUTS USING 29mm SPANNER.




#### 2 CONNECT **RETRO LIGHT** CABLE


1 PLACE CABLE GLAND NUT AND THREADED HEX NUT OVER RETRO LIGHT CABLE.

2 CONNECT WIRES TO TERMINAL BLOCK USING FLAT BLADE SCREW DRIVER.

## **INSTALLING CABLE JOINER**



4 TIGHTEN CABLE GLAND NUT USING 24mm SPANNER.






5 ATTACH MAIN BODY AND TIGHTEN USING 29mm SPANNER





#### **3** CONNECTING TO **EXISTING CABLE**




# LIGHT INSTALLATION

#### 1 COIL CABLE INTO NICHE




#### 2 ATTACH LIGHT FITTING TO NICHE




# **INSTALLATION COMPLETE**

INSTALLATION IS NOW COMPLETE. TURN POWER ON TO CONFIRM OPERATION.




# **WINTERISATION**

### **ELECTRICAL GROUNDING**

#### Manufacturers Statement

Per the NEC, NFPA 70, Article 680.23 [B][5], states that bonding shall not be required for luminaires that are listed for the application and have no non-current carrying metal parts. In addition, per Article 680.26 [B][4], exception states that Listed low-voltage lighting systems with non-metallic forming shells shall not require bonding.

Therefore, luminaires that are located in the Class 2 circuit with polymeric/non-current carrying metal parts are not required to be grounded / bonded.

Spa Electrics ATOM & QUANTUM [EM & WN9] luminaires with their plastic housing designs and plastic niches do not require grounding / bonding when operated within a Class 2 circuit supply.

Spa Electrics ATOM & QUANTUM (EM & WN9) lights have also been determined to comply with the applicable UL requirements for wet-niche, LED type Swimming Pool and Spa Luminaires.

### FCC COMPLIANCE STATEMENT

This device complies with part 15 of the FCC rules. Operation is subject to the following two (2) conditions:


- (1) This device may not cause harmful interference, and
